I, Daniel Srourian, declare:

1. I am counsel for Plaintiffs David Underwood and Duncan Meadows (“Plaintiffs”), in the above-captioned case. Based on that representation I have personal knowledge of the matters stated herein and could and would testify competently about them if called upon to do so. I make this declaration in further support of Plaintiffs’ Motion for Preliminary Approval of Class Action Settlement with defendant, Hapy Bear Surgery Center, LLC (“Defendant”), pursuant to the Court’s tentative ruling dated September 16, 2024, requesting that the parties further address various issues.

2. On April 15, 2024, Plaintiff David Underwood filed a class action complaint in the Superior County of the State of California, County of Tulare (the “Court”) entitled, *Underwood v. Hapy Bear Surgery Center, LLC*, Case No. VCU307987. On April 22, 2024, Plaintiff Duncan Meadows filed a putative class action against Defendant in the Tulare County Superior Court in California, Case No. VCU308221. On June 24, 2024, the class actions filed by Representative Plaintiffs Underwood and Meadows were consolidated into the *Underwood* action and captioned the *In re Hapy Bear Surgery Center Data Security Incident Litigation*.

3. Defendant denies all claims of wrongdoing or liability that Plaintiffs assert in the Complaint, and it contends that it has maintained, and continues to maintain, reasonable security information practices. Recognizing the risks and continued costs of litigation, Plaintiffs and Defendant decided to engage in private, arms-length negotiations to resolve all matters associated with the litigation. Ultimately, the Plaintiffs and Defendant participated in a full day mediation with retired Judge David E. Jones. Through Judge Jones, the basic terms of a settlement were negotiated and finalized. Class Counsel conducted a thorough examination and evaluation of the relevant law and facts to assess the merits of the claims to be resolved in this settlement and how best to serve the interests of the putative class in the Litigation. Based on this investigation and the negotiations described above at the mediation, Class Counsel concluded that the risks, uncertainty and cost of further pursuit of this Litigation, and the benefits to be

1 provided to the Settlement Class pursuant to the Settlement Agreement, that a settlement with
2 Defendant on the terms set forth in the Agreement is fair, reasonable, adequate and in the best
3 interests of the class.

4 4. The Settlement Agreement is fair, adequate, and reasonable. Settlement Class
5 Members were provided claims for: (i) reimbursements will provide up to \$500 per person and
6 reimbursement for lost time up to four hours per individual at the rate of \$25 per hour (\$90 per
7 individual) and (ii) Extraordinary Losses up to \$7,500 per person. All Settlement Class members
8 are further eligible to enroll in two (2) years of Credit Monitoring Services, upon submission of a
9 valid Claim Form regardless of whether the Settlement Class Member submits a claim for
10 reimbursement of Unreimbursed Economic Losses or Lost Time. And to account for California
11 specific statutes alleged in the operative Complaint, Class Members with a California residential
12 address are eligible to receive an additional payment of \$50. These amounts are similar to other
13 data breach class action cases that resolved early. Additionally, the Settlement requires HBCS to
14 undertake certain steps to fundamentally enhance its data security in order to secure Plaintiffs'
15 and Settlement Class Members' Personal Information against a future breach. Amount of
16 attorneys' fees was negotiated only after the Parties agreed to all substantive terms of the
17 settlement. Attached herein as **Exhibit 1** is a fully executed version of the Settlement Agreement.

18
19 5. Class Counsel obtained all available public records regarding the Data Security
20 Incident, as well as informal discovery related to the merits of Plaintiffs' claims, potential
21 defenses thereto, and class certification. With this information, Class Counsel were prepared and
22 were able to negotiate a settlement that provides substantial and certain relief for the Class that is
23 greater relief than many settlements in this arena provide.

24 6. In connection with this matter, I have spent a total of 193.7 hours, to date. Based
25 on the hours incurred to date, and my \$800.00 hourly rate, the total amount of fees incurred by
26 my firm for the entirety of this case is \$154,960. I anticipate spending an additional 10 hours to
27 see this matter through until completion, including but not limited to attending the Motion for
28

1 Final Approval, communicating with the settlement administrator, speaking with Class Members
2 with inquiries about the settlement and/or claims process, and eventually advising the Court of
3 the status of administration. My billing mirrors the development of the case as it unfolded before
4 this Court.

5 7. \$800.00 is the current hourly rate I customarily charge for my time. I have other
6 clients who pay this rate for my time working on that client's particular matter. In fact, the
7 majority of my clients (those charged on an hourly basis) pay for my time at this rate. Even for
8 those cases handled on a contingency basis, this hourly rate is reasonable in light of my relevant
9 experience handling these types of case.

10 8. I am a graduate of Southwestern Law School of Los Angeles and have been a
11 practicing attorney in California since 2012. I am admitted to practice law in the State of
12 California and multiple federal district courts. I primarily focus my practice on data breach class
13 action cases and have been actively involved in numerous class actions and complex litigation
14 involving wage and hour issues like the ones at issue in this case, including PAGA claims. I am
15 informed and believe through conversations with other attorneys, as well as reviewing
16 declarations filed by other attorneys, that my rate is lower than the normal hourly rate of partners
17 at other law firms practicing in this field. I believe my hourly rate to be reasonable.

18 9. I currently serve as counsel of record on approximately 150 class action data
19 breach cases across the country. Judges around the country have appointed Srourian Law Firm as
20 Lead or Co-Lead Counsel in class action data breach matters, including *Boyd et al. v. Prudential*
21 *Financial, Inc.* (2:24-cv-06818-SRC-AME) (D.N.J.), a national data breach involving
22 approximately 2.3 million individuals; *Malinowski et al. v. International Business Machine*
23 *Corporation, et al.* (7:23-cv-08421-NSR) (S.D. New York), a national data breach involving
24 approximately 500,000 individuals; *Conifer et al. v. Conifer Revenue Cycle Solutions, LLC, et al.*
25 (2:23-CV-01987 AB) (S.D.N.Y.), a national data breach involving approximately 100,000
26 individuals; *Lenaway v. Octapharma Plasma, Inc.* (3:24-CV-424-MOC) (W.D.N.C.), a national

1 data breach involving approximately 200,000 individuals; and *Feathers et al. v. On Q Financial*
2 *LLC* (CV-24-00811-PHX-SMB) (D. Ariz.), a national data breach involving approximately
3 211,000 individuals.

4 10. Srourian Law Firm has additionally been appointed to the Plaintiff's
5 Steering/Executive Committee for the following class action data breach cases: *Cain et al. v.*
6 *CGM, L.L.C* (1:23-cv-02604) (N.D. Ga.), *Hahn et al. v. Phoenician Medical Center, Inc.*,
7 (CV2023-010982) (Superior Court of the State of Arizona, County of Maricopa), *Dudurkaewa v.*
8 *Midfirst Bank and Midland Financial Co.*, (5:23-cv-00817-R) (W.D. Okla.), *Trottier v. Sysco*
9 *Corporation* (4:23-cv-01818) (S.D. Tex.), *Mathis v. Planet Home Lending, LLC* (3:24-cv-00127)

14 11. I began my work in the class action arena in 2014, representing employees across
15 the country in wage and hour class action cases for violations of the California Labor Code and
16 the Fair Labor Standards Act. Since that time, I have gained extensive class action litigation
17 experience, having vigorously litigated approximately 200 wage and hour class actions to date,
18 including conducting complex written discovery and taking depositions. Overall, since starting
19 the practice of law in 2013, I have conducted at least 300 depositions on various matters for
20 which I have served as plaintiff's counsel, as well as conducted three trials, one of which
21 produced a successful verdict in the amount of \$1,541,000 when Defendant's top pre-trial offer
22 was \$450,000.00, while another produced a successful jury verdict in the amount of
23 \$1,041,697.00 when Defendant's top pre-trial offer was a mere \$30,000.00.

24 12. Notable class action recoveries obtained by my office include the following:
25 *RCHS Wage and Hour Cases*, No. JCCP5243, (Riverside County, Ca.), \$6,000,000.00 recovered
26 on behalf of over 3,000 current/former restaurant employees (preliminary approval granted, final
27 approval pending); *Kirk McLemore et al. v. Nautilus Hyosung America, Inc.*, No. 2:17-cv-

1 02298-CBM (C.D. Cal.), \$3,182,979.00 recovered on behalf of nearly 1,000 current/former
2 nationwide ATM technicians (Final Approval granted in 2020 with no objections)¹; *Robert*
3 *Bennet v. 48Forty Solutions, LLC*, No. CVRI2201011 (Riverside County, Ca.) \$1,950,000.00
4 recovered on behalf of approximately 850 warehouse employees (Final Approval granted in
5 2024 with no objections); *Diego Zamudio v. Letter Ride*, No. RIC1805755 (Riverside County,
6 Ca.) \$1,000,000.00 recovered on behalf of approximately 1,000 delivery drivers (Final Approval
7 granted in 2019 with no objections); *Kevork Manoukian v. John Bean Technologies*, No.
8 BC688700 (Los Angeles County, Ca.) \$987,500.00 recovered on behalf of over 500 LAX airport
9 staff (Final Approval granted in 2020 with no objections); *Chelsea Medlock et al. v. MedMen*
10 *Dispensary*, No. 18STCV05391 (Los Angeles County, Ca.) \$975,000.00 recovered on behalf of
11 nearly 1,000 retail workers (Final Approval granted in 2021 with no objections).

13 13. I have also been selected to Super Lawyers from 2023-2025, in addition to being
14 selected for Super Lawyers – Rising Stars from 2016-2022.

15 14. To date, my firm has incurred \$3,948.46 in litigation costs for this action,
16 including filing fees, the service of summons and complaint, and mediation expenses for the
17 formal mediation conducted by the parties.

18 I declare under penalty of perjury under the laws of the State of California that the
19 foregoing declaration is true and correct.

EXHIBIT 1

SETTLEMENT AGREEMENT AND RELEASE

This Settlement Agreement and Release (“Settlement Agreement” or “Agreement”) is entered into by and between Hapy Bear Surgery Center, LLC, (“HBSC” or “Defendant”) and David Underwood and Duncan Meadows (collectively referred to herein as “Plaintiffs”), individually and on behalf of the Settlement Class, in the consolidated case of *In re Hapy Bear Surgery Center Data Security Incident Litigation*, Case No. VCU307987 pending in the Tulare County Superior Court. HBSC and Plaintiffs are each referred to as a “Party” and are collectively referred to herein as the “Parties.”

I. FACTUAL BACKGROUND AND RECITALS

1. On or around December 27, 2023, HBSC was a target of a cybersecurity incident involving unauthorized access to certain third-party applications utilized by HBSC. When HBSC detected the incident, it took action to contain it and remediate any issues related to the incident.

2. Following the December 2023 cybersecurity incident, multiple putative class action lawsuits were filed against HBSC.

3. On April 15, 2024, Plaintiff David Underwood filed a putative class action complaint against HBSC in the Tulare County Superior Court with the caption *Underwood v. Hapy Bear Surgery Center, LLC*, Case No. VCU307987 (“Underwood”). Underwood brought claims against HBSC related to the December 2023 cybersecurity incident.

4. On April 22, 2024, Plaintiff Duncan Meadows filed a putative class action complaint against HBSC in the Tulare County Superior Court with the caption *Meadows v. Hapy Bear Surgery Center, LLC*, Case No. VCU308221 (“Meadows”). Meadows brought claims against HBSC related to the December 2023 cybersecurity incident.

5. On June 24, 2024, the *Underwood* and *Meadows* actions were consolidated before Judge Gary M. Johnson of the Tulare County Superior Court under the caption of the first filed Underwood case titled *In re Hapy Bear Surgery Center Data Security Incident Litigation*, Case No. VCU307987 (the “Action”).

6. Plaintiffs collectively filed a consolidated complaint on July 24, 2024.

7. The Parties’ Counsel are experienced litigators in consumer protection, data privacy, and data breach litigation. The Parties exchanged confidential information related to the December 27, 2023 cybersecurity incident that allowed the Parties to assess all aspects of the case and meaningfully engage in arms-length settlement negotiations. HBSC provided informal discovery responses that included a summary of the facts based on the investigation into the cybersecurity incident as well as its recovery and restoration process and hardening measures. HBSC also provided and directed Plaintiffs to information regarding the approximate total number of US customers impacted by the incident. These discussions eventually led to a private mediation.

8. On July 19, 2024, the Parties conducted an all-day mediation with the Honorable David E. Jones of Resolute Dispute Resolution in an effort to reach a settlement agreement. The Parties reached a settlement agreement during the mediation.

9. Plaintiffs and Class Counsel conducted a comprehensive examination of the law and facts relating to the allegations in the Action and HBSC's potential defenses. Plaintiffs believe that the claims asserted in the Action have merit, that they would have ultimately succeeded in obtaining adversarial certification of the proposed Settlement Class, and that they would have prevailed on the merits at summary judgment or trial.

10. However, Plaintiffs and Class Counsel recognize that HBSC has raised factual and legal defenses in the Action that presented a significant risk that Plaintiffs may not prevail and/or that a class might not be certified for trial. Class Counsel have also taken into account the uncertain outcome and risks of any litigation, especially in complex actions, as well as difficulty and delay inherent in such litigation.

11. Plaintiffs and Class Counsel believe that this Agreement presents an exceptional result for the Settlement Class, and one that will be provided to the Settlement Class without delay. Plaintiffs and Class Counsel are satisfied that the terms and conditions of this Agreement are fair, reasonable, adequate, and based on good faith negotiations, and in the best interests of Plaintiffs and the Settlement Class. Therefore, Plaintiffs believe that it is desirable that the Released Claims be fully and finally compromised, settled, and resolved with prejudice, and forever barred pursuant to the terms and conditions set forth in the Settlement Agreement.

12. HBSC denies the material allegations in the Action, as well as any and all allegations of negligence, fault, wrongdoing or liability, and believes that it would have prevailed on the merits and that a class would not be certified for trial. Nevertheless, HBSC has similarly concluded that this settlement is desirable to avoid the time, risk, and expense of defending protracted litigation, and to avoid the risk posed by the Settlement Class's claims. HBSC thus desires to resolve finally and completely the pending and potential claims of Plaintiffs and the Settlement Class.

13. NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED by and among Plaintiffs, the Settlement Class, and Defendant that, subject to the approval of the Court after a hearing as provided for in this Settlement Agreement, and in consideration of the benefits flowing to the Parties from the Settlement set forth herein, the Released Claims shall be fully and finally compromised, settled, and released, and the Action shall be dismissed with prejudice or that judgment be entered in accordance with the settlement terms, upon and subject to the terms and conditions set forth in this Settlement Agreement.

II. DEFINITIONS

In addition to any definitions set forth elsewhere in this Settlement Agreement, the following terms shall have the meanings set forth below:

14. **“Action”** means the case captioned *In re Hapy Bear Surgery Center Data Security Incident Litigation*, Case No. VCU307987 pending in the Tulare County Superior Court.

15. **“Agreement”** or **“Settlement Agreement”** or **“Settlement”** means this Settlement Agreement and Release and the attached Exhibits.

16. **“Approved Claim(s)”** means a Claim Form submitted by a Settlement Class

member that (a) is timely and submitted in accordance with the directions on the Claim Form and the terms of this Agreement, (b) is fully completed and physically or electronically signed by the Settlement Class Member, and (c) satisfies the conditions of eligibility for a Settlement Payment as set forth in this Agreement and approved by the Settlement Administrator.

17. **“Claimant”** means an individual who has submitted a Claim Form.

18. **“Claims Deadline”** means the date by which all Claim Forms must be postmarked or submitted on the Settlement Website to be considered timely and shall be set as a date no later than ninety (90) days following the Notice Date, subject to Court approval. The Claims Deadline shall be clearly set forth in the Preliminary Approval Order, as well as in the Notice and the Claim Form.

19. **“Claim Form”** means the form which will be agreed upon by the Parties prior to seeking preliminary approval of this Settlement that Settlement Class Members may submit to obtain compensation under this Settlement Agreement. *See Exhibit 1.*

20. **“Class Counsel”** means attorneys Daniel Srourian of Srourian Law Firm, P.C. and Jason Wucetich of Wucetich & Korovilas LLP.

21. **“Class Representatives” or “Plaintiffs”** means the named Plaintiffs in the Action, David Underwood and Duncan Meadows.

22. **“Court”** means the Tulare County Superior Court, the Honorable Gary M. Johnson presiding, or any judge who shall succeed him as the Judge assigned to the Action.

23. **“Cy Pres”** means Privacy Rights Clearinghouse, a 501(c)(3) nonprofit organization.

24. **“Defendant”** means Hapy Bear Surgery Center, LLC.

25. **“Defendant’s Counsel” or “HBSC’s Counsel”** means attorney David Ross of Wilson Elser LLP.

26. **“Effective Date”** means one business day following the later of: (i) the date upon which the time expires for filing or noticing any appeal of the Final Approval Order; (ii) if there is an appeal or appeals, other than an appeal or appeals solely with respect to the Fee Award or Service Award, the date of completion, in a manner that finally affirms and leaves in place the Final Approval Order without any material modification, of all proceedings arising out of the appeal(s) (including, but not limited to, the expiration of all deadlines for motions for reconsideration or petitions for review and/or certiorari, all proceedings ordered on remand, and all proceedings arising out of any subsequent appeal(s) following decisions on remand); or (iii) the date of final dismissal of any appeal or the final dismissal of any proceeding on certiorari with respect to the Final Approval Order. If there are no timely objectors, the Effective Date is one day after the Final Approval Order is entered by the Court.

27. **“Escrow Account”** means the separate, interest-bearing escrow account to be established by the Settlement Administrator under terms acceptable to Class Counsel and

Defendant at a depository institution insured by the Federal Deposit Insurance Corporation. The money in the Escrow Account shall be invested in the following types of accounts and/or instruments and no other: (a) demand deposit accounts and/or (b) time deposit accounts and certificates of deposit, in either case with maturities of forty-five (45) days or less. Any interest earned on the Escrow Account shall inure to the benefit of the Settlement Class as part of the Settlement Payment, if practicable. The Settlement Administrator shall be responsible for all tax filings with respect to the Escrow Account.

28. **“Fee Award”** means the amount of attorneys’ fees awarded to Class Counsel by the Court to be paid out of the Settlement Fund.

29. **“Litigation Costs”** means the amount of litigation costs awarded to Class Counsel by the Court to be paid out of the Settlement Fund.

30. **“Final Approval Hearing”** means the hearing before the Court where Plaintiffs will request that the Final Approval Order be entered by the Court finally approving the Settlement as fair, reasonable, adequate, and approving the Fee Award, awarding Litigation Costs, and the Service Awards to the Class Representatives.

31. **“Net Settlement Fund”** means the non-reversionary cash fund made by Defendant of Six Hundred Seven Thousand Five Hundred Dollars (\$607,500.00) referenced in the Settlement Fund, less any Fee Award, Litigation Costs, Service Award to the Class Representatives, and Settlement Administration Expenses. The Settlement Administrator must use the funds available in the Net Settlement Fund (after payment of Notice and Administrative Expenses, Taxes and Tax-Related Expenses, the Fee Award and Expenses, and Service Awards) to make payments for Approved Claims in this order: Unreimbursed Economic Losses, followed by Credit Monitoring, followed by Lost Time.

32. **“Notice”** means the notice of the proposed Settlement and Final Approval Hearing which will be agreed upon by the Parties prior to seeking preliminary approval of this Settlement, and which is to be disseminated to the Settlement Class substantially in the manner set forth in this Settlement Agreement. The Parties agree the Notice fulfills the requirements of Due Process and Cal. Code Civ. Proc. § 382, and is substantially in the form of the Exhibits attached hereto. *See Exhibit 2.*

33. **“Notice Date”** means the date by which the Notice is disseminated to the Settlement Class and shall be a date no later than 30 days following the Court’s Preliminary Approval Order.

34. **“Objection/Exclusion Deadline”** means the date by which a written objection to the Settlement Agreement by a Class Member must be filed with the Court or a request for exclusion submitted by a person within the Settlement Class must be postmarked or received by the Settlement Administrator, which shall be designated as a date forty-five (45) days after the Notice Date, as approved by the Court. The Objection/Exclusion Deadline will be set forth in the Notice and on the Settlement Website.

35. **“Preliminary Approval Order”** means the Court’s order preliminarily approving the Agreement, certifying the Settlement Class for settlement purposes, and approving the form

and manner of the Notice.

36. “**Released Claims**” shall have the meaning ascribed to it as set forth in Paragraph 57 of this Settlement Agreement.

37. “**Released Parties**” means HBSC, and its parents, subsidiaries, divisions, predecessors and successors, and each of their respective past and present officers, directors, stockholders, partners, members, employees, executors, predecessors, successors, owners, attorneys, insurers, reinsurers, agents, and assigns.

38. “**Releasing Parties**” means Plaintiffs and each Settlement Class Member and their respective present or past heirs, executors, estates, administrators, assigns and agents.

39. “**Service Award**” means the award approved by the Court for the Class Representatives.

40. “**Settlement Administration Expenses**” means the expenses reasonably incurred by the Settlement Administrator in or relating to administering the Settlement, providing Notice, creating and maintaining the Settlement Website, receiving and processing Claim Forms, dispersing Settlement Payments, related tax expenses, fees of the escrow agent, and other such related expenses, with all such expenses to be paid from the Settlement Fund, as approved by the Court.

41. “**Settlement Administrator**” means the third-party settlement administrator agreed upon by the Parties, subject to approval of the Court, which will provide the Notice, create and maintain the Settlement Website, receive and process Claim Forms, transmit Settlement Payments on Approved Claims, be responsible for tax reporting, and perform such other settlement administration matters set forth herein or contemplated by the Settlement.

42. “**Settlement Class Member(s)**” shall mean each and every member of the Settlement Class, as defined in Paragraph 48 of this Settlement Agreement, who does not timely elect to be excluded from the Settlement Class.

43. “**Settlement Fund**” means the following: (1) the non-reversionary cash fund that shall be established by Defendant in the amount of Six Hundred Seven Thousand Five Hundred Dollars (\$607,500.00); and (2) Defendant’s Three Hundred Thirty Thousand Dollars (\$330,000.00) in security hardening measures resulting from the December 27, 2023 cybersecurity incident at issue in this Action, after the deduction of Settlement Administrator Expenses, Fee Award and Service Awards, and Litigation Costs. The Total Economic Benefits provided for in this Settlement is therefore up to approximately Nine Hundred Thirty Seven Thousand Five Hundred Dollars (\$937,500.00). Within ten (10) days of the entry of the Preliminary Approval Order, Defendant or any other party on behalf of Defendant shall deposit \$200,000 (Two Hundred Thousand Dollars) into the Escrow Account for the purpose of preliminary funding Settlement and its Administration, including the funding of Notice related costs. Within thirty (30) days of the Effective Date, Defendant or any other party on behalf of Defendant shall deposit \$407,500 (Four Hundred Seven Thousand Five Hundred Dollars) into the Escrow Account for the purpose of completing the funding of Settlement and its Administration. The Settlement Fund shall be kept in

the Escrow Account with permissions granted to the Settlement Administrator to access said funds until such time as the above-listed payments are made. In no event shall any amount paid by Defendant into the Escrow Account, or any interest earned thereon, revert to Defendant or any other Released Party, except if the Effective Date does not occur or Defendant does not exercise its right to terminate this Settlement as set forth in this Agreement.

44. “**Settlement Website**” means the website to be created, launched, and maintained by the Settlement Administrator, which will provide access to relevant settlement administration documents, including the Notice, relevant court filings, and the ability to submit Claim Forms online. The Settlement Website shall be live and active by the Notice Date, and the URL of the Settlement Website shall be www.HBSCDataSecurityIncident.com or such other URL as the Parties may subsequently agree to.

45. “**Total Economic Benefit**” means the non-reversionary cash Settlement Fund made by Defendant of Six Hundred Seven Thousand Five Hundred Dollars (\$607,500.00) and Defendant’s Three Hundred Thirty Thousand Dollars (\$330,000.00) in security hardening measures resulting from the December 27, 2023 cybersecurity incident at issue in this Action.

III. SETTLEMENT CLASS CERTIFICATION

46. For purposes of the Settlement only, the Parties stipulate and agree that: (1) the Settlement Class and Subclasses shall be certified in accordance with the definition contained in Paragraph 50, below; (2) Plaintiffs shall represent the Settlement Class for settlement purposes as the Class Representatives; and (3) Plaintiffs’ Counsel shall be appointed as Class Counsel.

47. HBSC does not consent to certification of the Settlement Class for any purpose other than to effectuate the Settlement. If the Court does not enter Final Approval of the Settlement, or if for any other reason final approval of the Settlement does not occur, is successfully objected to, or challenged on appeal, any certification of any Class will be vacated and the Parties will be returned to their positions with respect to the Action as if the Settlement Agreement had not been entered into. In the event that Final Approval of the Settlement is not achieved: (1) any Court orders preliminarily or finally approving the certification of any class contemplated by this Settlement Agreement shall be null, void, and vacated, and shall not be used or cited thereafter by any person or entity; and (2) the fact of the settlement reflected in this Settlement Agreement, that HBSC did not oppose the certification of a class under this Settlement Agreement, or that the Court preliminarily approved the certification of a Class, shall not be used or cited thereafter by any person or entity, including in any manner whatsoever, including without limitation any contested proceeding relating to the certification of any class.

48. Subject to Court approval, the Settlement Class consisting of the following subclasses shall be certified for settlement purposes:

- a. **Nationwide Class:** All persons whose personal identification information and data was stored in HBSC’s systems at the time of the December 27, 2023 cybersecurity incident and who were impacted by the cybersecurity incident. HBSC has confirmed that the number of Class Members impacted by the December 27, 2023 cybersecurity incident is 109,161

individuals.

- b. **California Subclass:** All members of the Nationwide Class who are also California residents at the time of the December 27, 2023 cybersecurity incident. HBSC has confirmed that the number of California residents at the time of the cybersecurity incident is 108,946 individuals.

49. Excluded from the Settlement Class are HBSC's officers, directors, and employees; any entity in which HBSC has a controlling interest; and the affiliates, legal representatives, attorneys, successors, heirs, and assigns of HBSC. Excluded also from the Settlement Class are members of the judiciary to whom this case is assigned, their families and members of their staff. Also excluded from the Settlement Class are non-natural persons.

IV. SETTLEMENT BENEFITS TO CLASS

50. Settlement Payments to Settlement Class Members

a. HBSC will agree to make the following compensation available to Settlement Class Members who submit an Approved Claim. Each Settlement Class Member shall be entitled to submit no more than one Claim for compensation as described in Paragraphs 51-53. Claims based on attestation may be made using a check-box on an online form or mailed form if requested. Settlement Payments exceeding \$600.00 may be treated as reportable/taxable income requiring the processing of W-9 forms by the Settlement Administrator.

b. **Cash Compensation:** From the Net Settlement Fund and upon submission of an Approved Claim, HBSC will provide:

- i. **Nationwide Class Member:** each Nationwide Class Member shall receive compensation for Ordinary Losses (as defined below);
 - ii. **California Subclass Member:** in addition to compensation for Ordinary Losses (as defined below) provided to the Nationwide Class, each California Subclass Member, who attests to being a resident of California, shall receive an additional payment of \$50.00.
- c. Should the Net Settlement Fund be insufficient to cover all Approved Claims in full, all such payments to Settlement Class Members will be reduced pro rata. To satisfy a pro rata reduction, the Parties intend to decrease the hourly rate of lost time provided under ordinary losses and described in paragraph 51. To the extent the Net Settlement Fund is not exhausted, Settlement Class Members who submit Approved Claims will receive an equal share as an enhancement of their cash compensation up to the Net Settlement Fund on a per person basis. To reduce or eliminate any residual amount, any remainder amounting to less than one cent per Claimant shall be allocated in the order that claims were received until the Settlement Fund is exhausted.

51. **Compensation for Ordinary Losses:** HBSC will provide compensation for unreimbursed losses, up to a total of \$500.00 per person, to Settlement Class Members upon submission of an Approved Claim and supporting documentation (if necessary) of the following categories of claimed losses:

a. *Out-of-pocket expenses incurred* as a result of the December 27, 2023 cybersecurity incident including, but not limited to, long distance phone charges, cell phone charges (only if charged by the minute), data charges (only if charged based on the amount of data used), bank fees (documented), credit monitoring (documented), or late fees (documented), all of which must be more likely than not caused by and fairly traceable to the December 27, 2023 incident and that are supported by documentation if necessary and sworn attestation that substantiates the full extent of the amount claimed;

b. *Up to four hours of lost personal time*, at \$25/hour, spent responding to the December 27, 2023 incident. Settlement Class and Subclass members may submit Claims for up to four hours of lost personal time with an attestation that they spent the claimed time responding to issues resulting from the December 27, 2023 incident.

52. **Compensation for Extraordinary Losses:** HBSC will provide compensation, up to a total of \$7,500.00 per person, to Settlement Class Members, upon submission of an Approved Claim and supporting documentation for proven monetary loss associated with fraud or identity theft if:

a. The loss is an actual, documented, and unreimbursed monetary loss;

b. The loss was more likely than not caused by and fairly traceable to the December 27, 2023 cybersecurity incident; and

c. The loss is not already covered by the **Compensation for Ordinary Losses** outlined in Paragraph 51 above.

Settlement Class Members with Extraordinary Losses set forth above must submit adequate documentation establishing their claims.

53. **Credit Monitoring:** “Credit Monitoring Services” means two (2) years of credit monitoring to Participating Settlement Class Members under the Settlement. These services include three-bureau credit monitoring; dark web monitoring; real-time inquiry alerts; and \$1 million in identity theft insurance, among other features. All Participating Settlement Class Members are eligible to enroll in two (2) years of Credit Monitoring Services, upon submission of a valid Claim Form regardless of whether the Participating Settlement Class Member submits a claim for reimbursement of Unreimbursed Economic Losses or Lost Time. The Settlement Administrator shall send an activation code to each valid Credit Monitoring Services claimant within forty-five (45) days of the Effective Date that can be used to activate Credit Monitoring Services. Such enrollment codes shall be sent via e-mail, unless the claimant did not provide an e-mail address, in which case such codes shall be sent via U.S. mail. Codes will be active for 180 days after the date of mailing, and may be used to activate the full term if used at any time during that 180 day period. The provider shall provide Credit Monitoring Services to all valid claimants

who timely activate those services for a period of two (2) years from the date of activation. Credit Monitoring Expenses, the administration of which will be overseen by Class Counsel, will be paid for from the Settlement Fund.

54. **Disposition of Residual Amounts:** If, despite the best efforts of the Settlement Administrator, a residual amount remains after distribution, all remaining balance shall be paid to the *Cy Pres* Recipient to ensure no funds revert to HBSC.

55. **Prospective Relief**

a. HBSC represents that it has taken and will continue to take measures to harden the security of the HBSC environment impacted by the December 27, 2023 cybersecurity incident. Those measures include, for various periods of time depending on the measure: expanding the scanning and monitoring program using insights from its investigation; supplementing HBSC's cyber security monitoring with additional third-party managed service monitoring; and deploying additional malware scanning tools across all products. The estimated cost of such measures is in excess of Three Hundred Thirty Thousand Dollars (\$330,000.00).

56. All Settlement Class members who fail to timely submit a claim for any benefits hereunder within the time frames set forth within, or such other period as may be ordered by the Court, or otherwise allowed, shall be forever barred from receiving any payment or benefits pursuant to the Settlement set forth within, but will in all other respects be subject to and bound by the provisions of the Settlement Agreement, the releases contained herein, and the Final Judgment.

V. **RELEASE**

57. **Release:** Upon the Effective Date, and in consideration of the settlement relief and other consideration described herein, the Releasing Parties, and each of them, shall be deemed to have released, and by operation of the Final Approval Order shall have, fully, finally, and forever released, acquitted, relinquished and completely discharged the Released Parties from any and all Released Claims—defined as follows:

Any and all claims, demands, actions, and causes of action that each and every Settlement Class Member has, had, or may ever have, known or unknown, suspected or unsuspected, fixed or contingent, accrued or unaccrued, arising out of or in any way related to the December 27, 2023 cybersecurity incident, including all claims or causes of action stemming from statutory, contractual, or common law rights under which the Settlement Class Members could seek to recover for any impact of the December 27, 2023 cybersecurity incident based on the allegations in the operative complaint, and all claims or causes of action that were or could have been brought in the Action based on the same factual predicate, whether or not those claims, demands, actions, or causes of action have been pleaded or otherwise asserted, including any and all damages, losses, or consequences thereof.

VI. **ADMINISTRATION OF THE SETTLEMENT AND CLASS NOTICE**

58. **Notice to the Settlement Class:** The Settlement Administrator shall provide notice to the Settlement Class Members and administer the Settlement under the Parties' supervision and

subject to the exclusive jurisdiction of the Court.

59. In connection with a motion seeking a Preliminary Approval Order, Class Counsel shall present the Notice Plan to the Court for approval, which shall advise the Settlement Class Members of their rights under the Settlement, including the right to be excluded from or object to the Settlement Agreement or its terms. In accordance with Paragraph 65 below, the Notice shall specify that any objection to this Settlement Agreement, and any papers submitted in support of said objection, shall be received by the Court at the Final Approval Hearing, only if, on or before the Objection/Exclusion Deadline approved by the Court and specified in the Notice, the person making an objection shall file notice of his or her intention to do so and at the same time (a) files copies of such papers he or she proposes to submit at the Final Approval Hearing with the Clerk of the Court, (b) files copies of such papers through the Court's electronic filing system if the objection is from a Settlement Class Member represented by counsel, who must also file an appearance, and (c) sends copies of such papers via e-mail, U.S. mail, hand, or overnight delivery service to Class Counsel and Defendant's Counsel.

60. Dissemination of the Notice shall be accomplished by the Settlement Administrator and shall comply with the following:

- a. *Class Member Information:* HBSC warrants that it has physical address contact information for the Settlement Class Members in the same manner as it had such information to send notice of the cybersecurity incident prior to the Action.
- b. *Settlement Website:* Prior to the dissemination of the Notice, the Parties agree to direct the Settlement Administrator to create a Settlement Website dedicated to providing information related to the Action and this Settlement, including the Notice contained within **Exhibit 2**. This Settlement Website will include the information in the Notice, access to relevant publicly available court documents relating to the Action and provide Settlement Class Members with the ability to make Claims for a cash benefit, and allow Settlement Claims Members to submit documents to supplement or cure deficient Claims.
- c. *Settlement Toll Free Number:* The Settlement Administrator shall establish and maintain a toll free telephone number with information relevant to this Settlement.
- d. *Direct Notice:* The Settlement Administrator shall provide Notice directly by mail to the Settlement Class no later than 30 days following entry of the Order granting Preliminary Approval. HBSC will provide contact information for the Settlement Class to the Administrator within 10 days of the Court issuing an order granting Preliminary Approval of the Settlement.

The administration of the Settlement is defined as the approval of the form of notice program and all related forms; creation and maintenance of Settlement Website; creation and maintenance of a

toll free number; day-to-day administration of the Settlement, including responding to Settlement Class member inquiries; delivery to the Parties of any requests for opt-outs or objections; communications to the Parties about any issues that may arise; and the preparation of an Affidavit of Fairness of the Notice Program to be submitted to the Court with the Motion for Final Approval. The notice program shall be designed to provide maximum clarity and ease of Claim submission.

61. **Maintenance of Records:** The Settlement Administrator shall maintain reasonably detailed records of its activities under this Settlement Agreement. The Settlement Administrator shall maintain all such records as required by applicable law in accordance with its business practices and such records will be made available to Class Counsel and Defendant's Counsel upon request. The Settlement Administrator shall also provide reports and other information to the Court as the Court may require. The Settlement Administrator shall provide weekly reports to Class Counsel and Defendant's Counsel with information concerning the Notice, the number of Claim Forms submitted, the number of Approved Claims, any requests for exclusion, and the administration and implementation of the Settlement. The Settlement Administrator shall make available for inspection by Defendant's Counsel all of the Approved Claim Forms received by the Settlement Administrator at any time upon reasonable notice. The Settlement Administrator shall confirm whether an individual submitted an Approved Claim Form upon request by Class Counsel. The Settlement Administrator shall make available for inspection by Class Counsel and Defendant's Counsel the Claim Forms for denied Claimants received by the Settlement Administrator at any time upon reasonable notice. Should the Court request, the Parties shall submit a timely report to the Court summarizing the work performed by the Settlement Administrator, including a post-distribution accounting of all amounts from the Settlement Fund paid to Settlement Class Members, the number and value of checks not cashed, the number and value of electronic payments unprocessed, and the amount distributed to any *cy pres* recipient.

62. **Processing Claim Forms:** The Settlement Administrator shall administer the relief provided by this Settlement Agreement by processing Claim Forms in a rational, responsive, cost effective, and timely manner. The Settlement Administrator shall be obliged to employ reasonable procedures to screen claims for abuse, fraud, and plausibility and deny Claim Forms where there is evidence of abuse or fraud. The Settlement Administrator shall determine whether a Claim Form submitted by a Settlement Class Member is an Approved Claim and shall reject Claim Forms that fail to (a) comply with the instructions on the Claim Form or the terms of this Agreement, or (b) provide full and complete information as requested on the Claim Form. In the event a person submits a timely Claim Form by the Claims Deadline, but the Claim Form is not otherwise complete, then the Settlement Administrator shall give such person reasonable opportunity to provide any requested missing information, which information must be received by the Settlement Administrator no later than twenty-eight (28) calendar days after the Claims Deadline. The Settlement Administrator shall promptly notify the Claimant, via the email address provided by the Claimant, of any Claim Forms rejected in whole or in part and provide its reasons. In the event the Settlement Administrator does not receive such information within twenty-eight (28) calendar days after the Claims Deadline, then any such claim shall be denied in whole or in part. The Settlement Administrator may contact any person who has submitted a Claim Form to obtain additional information necessary to verify the Claim Form. Any Claimant may dispute the Settlement Administrator's determination regarding their Claim Form. The Settlement Administrator shall advise the Parties of any such disputes and provide enough information to the Parties so they can provide their position on the dispute, if they so choose. The Settlement

Administrator will have the final determination as to the viability of any Claim Form submitted.

63. **Timing of Settlement Payments:** The Settlement Administrator shall make Settlement Payments contemplated in this Settlement Agreement to all Settlement Class Members, who, if necessary, have completed required tax forms, within forty-five (45) days after the Effective Date.

64. **Tax Reporting:** The Settlement Administrator shall be responsible for all tax filings related to the Escrow Account and making any required “information returns” as that term is used in 26 U.S.C. § 1 *et seq.* Neither Class Counsel nor Defendant make any representations regarding the tax treatment of the Settlement Fund nor is Defendant responsible for the tax treatment to the Settlement Payments received by any Settlement Class Member.

65. **Right to Object:** Any person in the Settlement Class who intends to object to this Settlement Agreement must present the objection in writing, which must be personally signed by the objector and must include: (a) the objector’s full name and current address, (b) a statement that he or she believes himself or herself to be a member of the Settlement Class, (c) whether the objection applies only to the objector, to a specific subset of the Settlement Class, or to the entire Settlement Class, (d) the specific grounds for the objection, (e) all documents or writing that the objector desires the Court to consider, (f) the name and contact information of any and all attorneys representing, advising, or in any way assisting the objector in connection with the preparation or submission of the objection or who may profit from the pursuit of the objection, and (g) a statement indicating whether the objector intends to appear at the Final Approval Hearing (either personally or through counsel, who must file an appearance or seek *pro hac vice* admission).

In addition, for any objection made with the assistance of any attorney, law firm staff, or other person who may profit from the pursuit of the objection to be valid, the objection must include the following: (a) a written statement of any legal support for such objection; (b) copies of any papers, briefs, or other documents upon which the objection is based that the objector wishes the judge to consider when reviewing the objection; (c) a list of all persons who will be called to testify in support of the objection, if any; and (d) a detailed list of any other objections and any orders pertaining to the prior objections, the objector, or his or her counsel or other person who may profit from the pursuit of the objection submitted in any action in the previous five (5) years. If the Class Member or his or her counsel or other person who may profit from the pursuit of the objection has not objected to any other class action Settlement in the previous five (5) years, he, she, or it shall affirmatively state so in the written materials provided in connection with the objection to this Settlement.

Any person in the Settlement Class who fails to timely file a written objection with the Court and notice of his or her intent to appear at the Final Approval Hearing in accordance with the terms of this Paragraph and as detailed in the Notice, and at the same time provide copies to designated counsel for the Parties, shall not be permitted to object to this Settlement Agreement at the Final Approval Hearing, shall be foreclosed from seeking any review of this Settlement Agreement or the Final Approval Order by appeal or other means, and shall be deemed to have waived his or her objections and be forever barred from making any such objections in the Action in any other action or proceeding. In order to be considered timely, objections must be actually filed with the Court by the deadline stated in the Notice.

66. **Right to Request Exclusion.** Any person in the Settlement Class may submit a request for exclusion from the Settlement on or before the Objection/Exclusion Deadline. To be valid, any request for exclusion must (a) be in writing; (b) identify the case name *In re Hapy Bear Surgery Center Data Security Incident Litigation*, Case No. VCU307987; (c) state the full name and current address of the person in the Settlement Class seeking exclusion; (d) be signed by the person(s) seeking exclusion; and (e) be postmarked or received by the Settlement Administrator on or before the Objection/Exclusion Deadline. However, where a request for exclusion is missing information, the Settlement Administrator shall contact the person seeking exclusion and give them an opportunity to provide the missing information, which must be provided within twenty-eight (28) days of the Claims Deadline. Any person who timely elects to request exclusion from the Settlement Class shall not (a) be bound by any orders or the Final Approval Order entered in the Action, (b) receive a Settlement Payment under this Settlement Agreement, (c) gain any rights by virtue of this Settlement Agreement, or (d) be entitled to object to any aspect of this Settlement Agreement or the Final Approval Order or Alternative Approval Order (as defined below). No person may request to be excluded from the Settlement Class through “mass” or “class” opt-outs.

VII. PRELIMINARY APPROVAL AND FINAL APPROVAL

67. Plaintiffs, through Class Counsel, shall submit this Settlement Agreement, together with its exhibits, to the Court and shall move the Court for Preliminary Approval of the settlement set forth in this Settlement Agreement, certification of the Settlement Class, appointment of Class Counsel and the Class Representative, and entry of the Preliminary Approval Order, which order shall seek a Final Approval Hearing date and approve the Notices and Claim Form for dissemination in accordance with the Notice Plan.

68. At the time of the submission of this Settlement Agreement to the Court as described above, the Parties shall request that, after Notice is given, the Court hold a Final Approval Hearing and approve the settlement of the Action as set forth herein.

69. At least sixteen court days prior to the Final Approval Hearing, or by some other date if so directed by the Court, Plaintiffs will move for (1) final approval of the Settlement; (2) final appointment of the Class Representatives and Class Counsel; and (3) final certification of the Settlement Class, including for the entry of a Final Order and Judgment identical in all material respects to the proposed Final Order and Judgment, and file a memorandum in support of the motion for final approval.

VIII. TERMINATION OF THE SETTLEMENT AGREEMENT

70. Subject to Paragraph 78 below, the Class Representatives, on behalf of the Settlement Class, or Defendant, shall have the right to terminate this Agreement by providing written notice of the election to do so to Class Counsel or Defendant’s Counsel within ten (10) days of any of the following events: (i) the Court’s refusal to enter the Preliminary Approval Order approving of this Agreement in any material respect; (ii) the Court’s refusal to enter the Final Approval Order in this Action in any material respect; (iii) the Court’s refusal to enter a final judgment in this Action in any material respect; (iv) the date upon which the Final Approval Order is modified or reversed in any material respect by the Court of Appeals or the Supreme Court; or (v) the date upon which an Alternative Approval Order is modified or reversed in any material

respect by the Court of Appeals or the Supreme Court. The Party who elects to terminate this Agreement shall be exclusively responsible for payment of the Settlement Administrator's costs/fees incurred up to the point of termination. HBSC shall have the right to terminate this Agreement by providing written notice of the election to do so to Class Counsel within five (5) days of notification that 2% or more of persons in the Settlement Class have submitted a timely request for exclusion from the Settlement. Upon such an election by HBSC, the termination of the Settlement will be treated as though Final Approval was not obtained under Paragraph 47 above and Paragraphs 75 and 76 below.

IX. SERVICE AWARDS AND CLASS COUNSEL'S ATTORNEYS' FEES AND REIMBURSEMENT OF EXPENSES

71. Defendant agrees that Class Counsel is entitled to reasonable attorneys' fees and unreimbursed expenses incurred in the Action as the Fee Award from the Settlement Fund. The amount of the Fee Award shall be determined by the Court based on a motion for such from Class Counsel. Class Counsel has agreed, with no consideration from Defendant, to limit their request for attorneys' fees to one-third (1/3rd) of the Settlement Fund. Plaintiffs will also separately seek their Litigation Costs not to exceed \$20,000.00 to be paid from the Settlement Fund. Payment of the Fee Award and Litigation Costs shall be made from the Settlement Fund and should the Court award less than the amount sought by Class Counsel, the difference in the amount sought and the amount ultimately awarded pursuant to this Paragraph shall remain in the Settlement Fund and be distributed to Settlement Class Members with Approved Claims as Settlement Payments. The Fee Award and Litigation Costs shall be payable within twenty-five (25) business days after the Effective Date. Payment of the Fee Award shall be made by the Settlement Administrator via wire transfer to accounts designated by Class Counsel after providing necessary information for electronic transfer.

72. In recognition of Plaintiffs' efforts on behalf of the Settlement Class, and subject to Court approval, Class Counsel may apply to the Court for an award for each Plaintiff of up to Five Thousand Dollars (\$5,000) from the Settlement Fund ("Service Award"), in addition to any Settlement Payment pursuant to this Settlement Agreement. Should the Court award less than this amount, the difference in the amount sought and the amount ultimately awarded pursuant to this Paragraph shall remain in the Settlement Fund and be distributed to Settlement Class Members as Settlement Payments. Any Service Awards shall be paid from the Settlement Fund (in the form of a check to the Class Representative that is sent care of Class Counsel), within twenty-five (25) business days after the Effective Date.

X. CONFIRMATORY DISCOVERY

73. In addition to the informal discovery conducted by the parties prior to the July 19, 2024 mediation in this matter, this Settlement Agreement is subject to further confirmatory discovery regarding the factual premises underlying the parties' negotiations and resulting settlement terms. HBSC agrees to work cooperatively with Plaintiffs to provide this confirmatory discovery, which is a material condition of this Settlement.

XI. CONDITIONS OF SETTLEMENT, EFFECT OF DISAPPROVAL, CANCELLATION OR TERMINATION.

74. The Effective Date shall not occur unless and until each and every one of the following events occurs, and shall be the date upon which the last (in time) of the following events occurs subject to the provisions in Paragraph 75:

- a. This Agreement has been signed by the Parties, Class Counsel and Defendant's Counsel;
- b. The Court has entered a Preliminary Approval Order;
- c. The Court has entered a Final Approval Order, or a judgment materially identical to this Settlement Agreement that has become final and no longer appealable, following Notice to the Settlement Class and a Final Approval Hearing, as provided in the Federal Rules of Civil Procedure; and
- d. In the event that the Court enters an approval order and final judgment in a form other than that provided above (the "Alternative Approval Order") to which the Parties have consented, that Alternative Approval Order has become final and no longer appealable.

75. If some or all of the conditions specified in Paragraph 74 are not met, or in the event that this Agreement is not approved by the Court, or the settlement set forth in this Agreement is terminated or fails to become effective in accordance with its terms, then this Agreement shall be canceled and terminated subject to Paragraph 76, unless Class Counsel and Defendant's Counsel mutually agree in writing to proceed with this Settlement Agreement. If any Party is in material breach of the terms hereof, any other Party, provided that it is in substantial compliance with the terms of this Agreement, may terminate this Settlement Agreement on notice to all other Parties. Notwithstanding anything herein, the Parties agree that the following shall not prevent the Settlement Agreement from becoming effective, nor shall they be grounds for termination of the Agreement: (1) the Court's decision as to the amount of the Fee Award to Class Counsel set forth above or the Service Award to the Class Representative, regardless of the amounts awarded, or (2) the Court's determination that it lacks jurisdiction such that the Parties' Agreement will be renewed in an appropriate forum.

76. If this Settlement Agreement is terminated or fails to become effective for the reasons set forth above, the Parties shall be restored to their respective positions in the Action as of the date of the signing of this Agreement. In such event, any Final Approval Order or other order entered by the Court in accordance with the terms of this Agreement shall be treated as vacated, *nunc pro tunc*, and the Parties shall be returned to the *status quo ante* with respect to the Action as if this Settlement Agreement had never been entered into.

XII. MISCELLANEOUS PROVISIONS.

77. The Parties: (a) acknowledge that it is their intent to consummate this Agreement; and (b) agree, subject to their fiduciary and other legal obligations, to cooperate to the extent reasonably necessary to effectuate and implement all terms and conditions of this Agreement and

to exercise their reasonable best efforts to accomplish the foregoing terms and conditions of this Settlement Agreement. Class Counsel and Defendant's Counsel agree to cooperate with one another in seeking entry of the Preliminary Approval Order and the Final Approval Order, and promptly to agree upon and execute all such other documentation as may be reasonably required to obtain final approval of the Settlement Agreement.

78. Each signatory to this Agreement represents and warrants (a) that he, she, or it has all requisite power and authority to execute, deliver and perform this Settlement Agreement and to consummate the transactions contemplated herein, (b) that the execution, delivery and performance of this Settlement Agreement and the consummation by it of the actions contemplated herein have been duly authorized by all necessary corporate action on the part of each signatory, and (c) that this Settlement Agreement has been duly and validly executed and delivered by each signatory and constitutes its legal, valid and binding obligation.

79. The Parties intend this Settlement Agreement to be a final and complete resolution of all disputes between them with respect to the Released Claims by Plaintiffs and the other Settlement Class Members, and each or any of them, on the one hand, against the Released Parties, and each or any of the Released Parties, on the other hand. Accordingly, the Parties and their attorneys agree not to assert that the Action was brought by Plaintiffs or defended by Defendant, or each or any of them, in bad faith or without a reasonable basis. Plaintiffs, Defendant, and their respective counsel further agree not to make defamatory or disparaging remarks, comments, or statements concerning Defendant or Plaintiffs in media outlets or on social media.

80. The Parties have relied upon the advice and representation of their respective counsel, selected by them, concerning the claims hereby released. The Parties have read and understand fully this Settlement Agreement and have been fully advised as to the legal effect hereof by counsel of their own selection and intend to be legally bound by the same.

81. Whether the Effective Date occurs or this Settlement is terminated, neither this Settlement Agreement nor the Settlement contained herein, nor any court order, communication, act performed or document executed pursuant to or in furtherance of this Settlement Agreement or the Settlement:

a. is, may be deemed, or shall be used, offered or received against the Released Parties, or each or any of them as an admission, concession or evidence of, the validity of any Released Claims, the appropriateness of class certification, the truth of any fact alleged by Plaintiffs, the deficiency of any defense that has been or could have been asserted in the Action, the violation of any law or statute, the reasonableness of the Settlement Fund, Settlement Payment or the Fee Award, or of any alleged wrongdoing, liability, negligence, or fault of the Released Parties, or any of them;

b. is, may be deemed, or shall be used, offered or received against Defendant as, an admission, concession or evidence of any fault, misrepresentation or omission with respect to any statement or written document approved or made by the Released Parties, or any of them;

c. is, may be deemed, or shall be used, offered or received against Plaintiffs or

the Settlement Class, or each or any of them as an admission, concession or evidence of, the infirmity or strength of any claims asserted in the Action, the truth or falsity of any fact alleged by Defendant, or the availability or lack of availability of meritorious defenses to the claims raised in the Action;

d. is, may be deemed, or shall be used, offered or received against the Released Parties, or each or any of them as an admission or concession with respect to any liability, negligence, fault or wrongdoing as against any Released Parties, in any civil, criminal or administrative proceeding in any court, administrative agency or other tribunal. However, the Settlement, this Settlement Agreement, and any acts performed and/or documents executed in furtherance of or pursuant to this Settlement Agreement and/or Settlement may be used in any proceedings as may be necessary to effectuate the provisions of this Settlement Agreement. Moreover, if this Settlement Agreement is approved by the Court, any of the Released Parties may file this Settlement Agreement and/or the Final Approval Order in any action that may be brought against such parties in order to support a defense or counterclaim based on principles of *res judicata*, collateral estoppel, release, good faith settlement, judgment bar or reduction, or any other theory of claim preclusion or issue preclusion, or similar defense or counterclaim;

e. is, may be deemed, or shall be construed against Plaintiffs and the Settlement Class, or each or any of them, or against the Released Parties, or each or any of them, as an admission or concession that the consideration to be given hereunder represents an amount equal to, less than or greater than that amount that could have or would have been recovered after trial; and

f. is, may be deemed, or shall be construed as or received in evidence as an admission or concession against Plaintiffs and the Settlement Class, or each and any of them, or against the Released Parties, or each or any of them, that any of Plaintiffs' claims are with or without merit or that damages recoverable in the Action would have exceeded or would have been less than any particular amount.

82. The headings used herein are used for the purpose of convenience only and are not meant to have legal effect.

83. The waiver by one Party of any breach of this Settlement Agreement by any other Party shall not be deemed as a waiver of any other prior or subsequent breaches of this Settlement Agreement.

84. All of the Exhibits to this Settlement Agreement are material and integral parts hereof and are fully incorporated herein by reference.

85. This Settlement Agreement and its Exhibits set forth the entire agreement and understanding of the Parties with respect to the matters set forth herein, and supersede all prior negotiations, agreements, arrangements and undertakings with respect to the matters set forth herein. No representations, warranties or inducements have been made to any Party concerning this Settlement Agreement or its Exhibits other than the representations, warranties and covenants contained and memorialized in such documents. This Settlement Agreement may be amended or

modified only by a written instrument signed by or on behalf of all Parties or their respective successors-in-interest.

86. Except as otherwise provided herein, each Party shall bear its own attorneys' fees and costs incurred in any way related to the Action.

87. Plaintiffs represent and warrant that they have not assigned any claim or right or interest relating to any of the Released Claims against the Released Parties to any other person or party and that they are fully entitled to release the same.

88. Each counsel or other Person executing this Settlement Agreement, any of its Exhibits, or any related settlement documents on behalf of any Party hereto, hereby warrants and represents that such Person has the full authority to do so and has the authority to take appropriate action required or permitted to be taken pursuant to the Settlement Agreement to effectuate its terms.

89. This Settlement Agreement may be executed in one or more counterparts. All executed counterparts and each of them shall be deemed to be one and the same instrument. Signature by digital, facsimile, or in PDF format will constitute sufficient execution of this Settlement Agreement. A complete set of original executed counterparts shall be filed with the Court if the Court so requests.

90. The Court shall retain jurisdiction with respect to implementation and enforcement of the terms of this Settlement Agreement, and all Parties hereto submit to the jurisdiction of the Court for purposes of implementing and enforcing the settlement embodied in this Settlement Agreement.

91. This Settlement Agreement shall be governed by and construed in accordance with the laws of the State of California without reference to the conflicts of law provisions thereof.

92. This Settlement Agreement is deemed to have been prepared by counsel for all Parties, as a result of arm's-length negotiations among the Parties. Whereas all Parties have contributed substantially and materially to the preparation of this Settlement Agreement, it shall not be construed more strictly against one Party than another.

93. Unless otherwise stated herein, any notice required or provided for under this Settlement Agreement shall be in writing and shall be sent by electronic mail or hand delivery, as follows:

A California court ordered this notice. This is not a solicitation from a lawyer.

A Settlement has been reached in a class action against Hapy Bear Surgery Center, LLC (“HBSC”) in an action arising out of a cyberattack during which a hacker may have gained access to personally identifiable information (“PII”) and protected health information (“PHI”) stored by HBSC that occurred on or before December 27, 2023 (“Data Security Incident”). HBSC announced the Data Security Incident in April 2024. The lawsuit was filed asserting claims against HBSC relating to the Data Security Incident. HBSC denies all of the claims and denies that it did anything wrong.

WHAT CAN I GET? The settlement provides the following relief to people who submit a valid claim form:

- (1) up to **\$500** in documented ordinary out-of-pocket losses and up to four hours of time at \$25 per hour reasonably spent responding to the Data Security Incident;
- (2) up to **\$7,500** in reimbursement for documented extraordinary out-of-pocket losses related to the Data Security Incident;
- (3) two years of additional Credit Monitoring Services; and
- (4) California Residents are eligible to receive an additional \$50 payment.

WHO IS INCLUDED? You received this notice because HBSC’s records show you are a member of the Class. BASIC INFORMATION

1. Why was this Notice issued?

The Court authorized this notice because you have a right to know about the proposed settlement in this Class Action and about all of your options before the Court decides whether to give “Final Approval” to the settlement. This notice explains the legal rights and options that you may exercise before the Court decides whether to approve the settlement.

Judge Gary M. Johnson of the Superior Court of California, County of Tulare, is overseeing this case. The case is known as *In re Hapy Bear Surgery Center Data Security Incident Litigation*, Case No. VCU307987 (the “Lawsuit”). The people who filed the Lawsuit are called the Plaintiffs. HBSC is called the Defendant.

2. What is this lawsuit about?

Plaintiffs claim HBSC failed to prevent the Data Security Incident and assert claims including: (i) negligence; (ii) negligence per se; (iii) breach of implied contract; (iv) violation of the California Confidentiality of Medical Information Act; (v) violation of the California Unfair Competition Law; (vi) unjust enrichment; (vii) declaratory judgment; (viii) violation of the California Customer Records Act; and (ix) invasion of privacy. The Lawsuit seeks, among other things, payment for persons whose personal information was at issue in the Data Security Incident.

HBSC has denied and continues to deny all of the claims made in the Lawsuit, as well as all charges of wrongdoing or liability against it.

3. What is a class action?

In a class action, one or more people called “Plaintiff(s)” or “Representative Plaintiff(s)” (in this case, David Underwood and Duncan Meadows) sue(s) on behalf of all people who they allege have similar claims. One Court and one judge resolves the issues in the case.

4. Why is there a Settlement?

The Court did not decide in favor of Plaintiffs or HBSC. Instead, the parties negotiated a settlement that allows both Plaintiffs and HBSC to avoid the risks and costs of lengthy and uncertain litigation and the uncertainty of trial and appeals. The settlement allows people in the class to participate in a settlement (“Settlement Class members”) to obtain benefits without further delay. The Representative Plaintiffs and their attorneys believe the settlement is best for all Settlement Class members. The settlement does not mean that HBSC did anything wrong.

WHO IS IN THE SETTLEMENT?

5. How do I know if I am included in the Settlement?

You are part of this settlement if you are an individual residing in the United States and your personal information was involved in the 2023 Data Security Incident discovered on or about December 27, 2023, including those to whom HBSC or its authorized representative sent notice concerning the Data Security Incident.

Specifically excluded are: (i) HBSC and HBSC's parents, subsidiaries, affiliates, officers and directors, and any entity in which HBSC has a controlling interest; all individuals who make a timely election to be excluded from this settlement using the correct protocol for opting out; any and all federal, state or local governments, including but not limited to their departments, agencies, divisions, bureaus, boards, sections, groups, counsels and/or subdivisions; and all judges assigned to hear any aspect of this litigation, as well as their immediate family members.

6. What if I am not sure whether I am included in the settlement?

If you are not sure whether you are included in the settlement, or have any other questions related to the settlement, you may:

THE SETTLEMENT BENEFITS

7. What does the settlement provide?

Under the terms of the settlement, there are three kinds of compensation available: (1) up to **\$500** in documented ordinary out-of-pocket losses and up to four (4) hours of time at \$25 per hour reasonably spent responding to the Data Security Incident; (2) up to **\$7,500** in reimbursement for documented extraordinary out-of-pocket losses related to the Data Security Incident; and (3) two years of additional Credit Monitoring Services. You may submit a claim for any or all of the above-listed remedies. In addition to the above, Settlement Class members who are California residents are also eligible to receive an additional payment of \$50.00. To claim each type of remedy, you must provide information and documentation with the Claim Form, as described on the Claim Form.

HBSC has also agreed that it has and will continue to undertake certain reasonable steps to enhance the security deployed to secure access to its data network.

8. What compensation is available?

Ordinary Expense and Time Reimbursements: Settlement Class members are eligible to claim up to \$500, which may be decreased based on the number of claims and available funds, in reimbursement for the following:

- Out of pocket expenses, namely, postage, copying, scanning, faxing, mileage and other travel-related charges, parking, notary charges, research charges, cell phone charges (only if charged by the minute), long distance phone charges, data charges (only if charged based on the amount of data used), text message charges (only if charged by the message), bank

fees, accountant fees, credit monitoring fees, and attorneys' fees, all of which must be fairly traceable to the Data Security Incident and must not have been previously reimbursed by a third party; and

- Up to four (4) hours of lost time, at \$25/hour for time spent dealing with the Data Security Incident.

Extraordinary Losses: HBSC will provide compensation, up to a total of \$7,500.00 per person, to Settlement Class members, upon submission of an Approved Claim and supporting documentation for proven monetary loss associated with fraud or identity theft if:

- If the loss is actual, documented and an unreimbursed monetary loss;
- The loss was more than likely than not caused by and fairly traceable to the Data Security Incident; and
- The loss is not already covered by the Ordinary Expense Reimbursement defined above.

Credit Monitoring: "Credit Monitoring Services" means two (2) years of credit monitoring to Participating Settlement Class members under the Settlement. These services include three-bureau credit monitoring; dark web monitoring; real-time inquiry alerts; and \$1 million in identity theft insurance, among other features. All Settlement Class members are eligible to enroll in two (2) years of Credit Monitoring Services, upon submission of a valid Claim Form regardless of whether the Settlement Class Member submits a claim for reimbursement of Unreimbursed Economic Losses or Lost Time. The Settlement Administrator shall send an activation code to each valid Credit Monitoring Services claimant within forty-five (45) days of the Effective Date that can be used to activate Credit Monitoring Services. Such enrollment codes shall be sent via e-mail, unless the claimant did not provide an e-mail address, in which case such codes shall be sent via U.S. mail. Codes will be active for 180 days after the date of mailing, and may be used to activate the full term if used at any time during that 180 day period. The provider shall provide Credit Monitoring Services to all valid claimants who timely activate those services for a period of two (2) years from the date of activation.

California Residents: Class Members who attest to being a resident of California shall receive an additional payment of \$50.

HOW TO GET BENEFITS

9. How do I get benefits?

To receive a payment or credit monitoring services from the settlement, you must complete a Claim Form. You may download a copy of the Claim Form at [www.\[website\].com](http://www.[website].com), or you may request one by mail by calling (NUMBER). To complete the Claim Form, please read the instructions carefully, fill out the Claim Form, provide reasonable documentation (where applicable), and submit your Claim online or mail it postmarked no later than (CLAIM DEADLINE) to:

10. How will claims be decided?

The Claims Administrator will initially decide whether the information provided on a Claim Form is complete and valid. The Claims Administrator may request additional information from any claimant. If the claimant does not timely provide the required information, the Claim will be

considered invalid and will not be paid. If the claim is rejected in whole or in part, for any other reason, then the Claims Administrator shall refer the claim to the Representative Plaintiffs, HBSC and their counsel for a determination.

REMAINING IN THE SETTLEMENT

11. Do I need to do anything to remain in the settlement?

You do not have to do anything to remain in the settlement, but if you want a payment, you must submit a Claim Form postmarked or submitted online by **[CLAIM DEADLINE]**.

12. What am I giving up as part of the settlement?

By not timely opting-out of the class, all of the Court's orders will apply to you, and you give HBSC a "Release." A Release means you cannot sue or be part of any other lawsuit against HBSC about the claims or issues in this lawsuit (relating to the Data Security Incident), and you will be bound by the settlement. The specific claims you are giving up against HBSC and related persons or entities are called "Released Claims." The Released Claims are defined in the Settlement Agreement, which is available under the Important Documents page at [www.\[website\].com](http://www.[website].com). The Settlement Agreement describes the Released Claims with specific and accurate legal descriptions, so read it carefully.

EXCLUDING YOURSELF FROM THE SETTLEMENT

If you do not want a payment from this settlement, but you want to keep the right to sue HBSC about issues in this case, then you must take steps to get out of the Settlement Class. This is called excluding yourself from – or is sometimes referred to as “opting out” of – the Settlement Class.

13. If I exclude myself, can I get a payment from this settlement?

No. If you exclude yourself, you will not be entitled to any benefits of the settlement. You will also not be bound by any judgment in this case.

14. If I do not exclude myself, can I sue HBSC for the same thing later?

No. Unless you exclude yourself, you give up any right to sue HBSC for the Claims that this settlement resolves. You must exclude yourself from the Settlement Class to start your own individual lawsuit or to be part of any different lawsuit relating to the claims in this case. If you exclude yourself, do not submit a Claim Form to ask for a payment.

15. How do I get out of the settlement?

To exclude yourself from the settlement, send a letter that says you want to be excluded from the settlement in *In re Hapy Bear Surgery Center Data Security Incident Litigation*, Case No. VCU307987 (Tulare County, California) (“Exclusion Request”). Include your name, address, and signature. Your Exclusion Request must be postmarked by **[EXCLUSION DEADLINE]** and mailed to:

THE LAWYERS REPRESENTING YOU

16. Do I have a lawyer in this case?

Yes. The Court appointed Daniel Srourian of Srourian Law Firm, P.C. and Jason M. Wucetich of Wucetich & Korovilas LLP to represent you and other Settlement Class members. These lawyers are called Settlement Class Counsel. You will not be charged for these lawyers. If you want to be represented by your own lawyer, you may hire one at your own expense.

17. How will Settlement Class Counsel be paid?

If the settlement is approved and becomes final, Settlement Class Counsel will ask the Court to award attorneys' fees of \$312,500 and costs not to exceed \$20,000. Settlement Class Counsel will also request approval of a service award to each of the Representative Plaintiffs in the amount of \$5,000. If approved, these amounts, as well as the costs of notice and settlement administration, will be paid separately by HBSC and will not reduce the amount of total payments available to Settlement Class members.

OBJECTING TO THE SETTLEMENT

18. How do I tell the Court that I do not like the settlement?

If you are a Settlement Class member, you can object to the settlement if you do not like it or some part of it. You can give reasons why you think the Court should not approve the settlement. The Court will consider your views before making a decision. To object, you must file with the Court and mail or email copies to Class Counsel and HBSC's counsel a written notice stating that you object to the settlement. Your objection must include all of the following information: (i) your full name and address; (ii) the case name and docket number - *In re Hapy Bear Surgery Center Data Security Incident Litigation*, Case No. VCU307987 (Tulare County, California); (iii) proof that you are a member of the Settlement Class (e.g., copy of your settlement notice, a copy of original notice of the Data Security Incident, or a statement explaining why you believe you are a Settlement Class member); (iv) a written statement of all grounds for the objection, accompanied by any legal support for the objection you believe applicable; (v) the identity of any and all counsel representing you in connection with the objection; (vi) a statement whether you and/or your counsel will appear at the Final Approval Hearing; and (vii) your signature or the signature of your duly authorized attorney or other duly authorized representative (if any) representing you in connection with the objection.

Your written notice of an objection, in the appropriate form, must be mailed, with a postmark date no later than [DATE], to all of the following:

The Court may elect to hear your oral objection, even if you do not follow the above procedure, at the Final Approval Hearing, however, the Parties reserve the right to challenge the objection of any Settlement Class Member who does not follow the above procedure.

19. What is the difference between objecting and asking to be excluded?

Objecting is telling the Court that you do not like the settlement and why you do not think the Court should approve it. You can object only if you do not exclude yourself from the Settlement Class. Excluding yourself is telling the Court that you do not want to be part of the Settlement Class. If you exclude yourself, you have no basis to object because the case no longer affects you.

THE COURT’S FINAL APPROVAL HEARING

20. When and where will the Court decide whether to approve the settlement?

The Court will hold a Final Approval Hearing on **DATE** at **[TIME]** in the **TBD**. At this hearing, the Court will consider whether the settlement is fair, reasonable, and adequate. The Court will take into consideration any properly filed written objections and may also listen to people who have asked to speak at the hearing (see Question 18). The Court will also decide whether to approve fees and costs to Settlement Class Counsel, and the service award to the Representative Plaintiffs.

21. Do I have to attend the Final Approval Hearing?

No. Settlement Class Counsel will present the Settlement Agreement to the Court. You or your own lawyer are welcome to attend at your own expense, but you are not required to do so. If you send an objection, you do not have to come to the Court to talk about it. As long as you filed your written objection on time with the Court and served it according to the instructions provided in Question 18, the Court will consider it.

22. May I speak at the Final Approval Hearing?

You may ask the Court for permission to speak at the Final Approval Hearing. To do so, you must file and serve an objection according to the instructions in **Question 18**, including all the information required.

IF YOU DO NOTHING

23. What happens if I do nothing?

If you do nothing, you will get no monetary benefits from this settlement. Once the Court grants the settlement Final Approval and the judgment becomes final, you will not be able to start a lawsuit, continue with a lawsuit, or be part of any other lawsuit against HBSC about the legal issues in this case, ever again.

You must exclude yourself from the settlement if you want to retain the right to sue HBSC for the Claims resolved by this settlement.
