CLAIM ACTIVITY

The deadline for Settlement Class Members to submit a Claim Form was February 4, 2025.
 As of February 12, 2025, EisnerAmper received 2,827 claim submissions, of which 2,688 submissions have
 been determined to be non-duplicative and from Settlement Class Members.

Table 1 below provides the summary statistics of claim submissions received. Table 2 below
 provides a summary of the approved claims and estimated awards by category as of February 12, 2025. If
 Attorneys' Fees, Costs, and Service Awards are approved as requested in the Plaintiffs' Motion for Fees,
 Costs and Enhancement Award, factoring in the costs of notice and administration, and the number of claims
 approved to date, EisnerAmper anticipates for payments to Settlement Class Members to be reduced pro rata.
 EisnerAmper will continue to intake and analyze claims submitted to the Settlement P.O. Box, postmarked
 by the claims filing deadline of February 4, 2025.
